How to Apply:

Enrolment will be made on receipt of the nomination form enclosed. The nomination along with the participation fee may be forwarded to us so as to reach us latest by **10 December 2022.** The intake of participants for the programme will be on a "first come first served basis". Nominations may be forwarded to us as early as possible. Once the nominations are confirmed, BIRD shall send the details of the participants being selected for participation in the programme.

Once the seats are filled, the nominations may be closed even before the due date indicated above.

Medical Facilities:
